October 6, 2022  
Meeting Minutes

1800 – President Brad Winters opened the meeting.

Thirteen members were present: Secretary has the sign in list, if needed.

Kellie Carlsen read the August minutes. Tom made a motion to accept the minutes as read. John seconded the motion. All approved.

There were no minutes for the September meeting.

Richard W. presented the treasurer's report: \$13,452.65 is in the General Fund and \$81,098.77 is in the Norm May account.

Ed made a motion to accept the treasurer's report as presented with Tom seconding the motion. All approved

We currently have 185 members.

Old Business:

1. The pistol range construction is complete. A window cracked and will be replaced by the contractor.
  - a. The county permit to establish an address was \$223.39
  - b. The invoice for the remainder of the project is \$6,649.50

Additional work to be done by the gun club will be benches, gravel and an awning on the front providing for weather protection.

There was consensus for Ed to use the club debit card to purchase supplies for building the benches.

2. Richard W. sent out the Winter-Spring newsletter
3. Brad talked to Chris about the \$35 late charge on the weed spraying. That amount will be taken off of next years spraying charge.

It was recommended that future spraying be extended out by 200 yards.

4. Tom gave an update on the clay pigeon thrower. He is working on getting a reduced rate from the manufacturer.

## New Business:

1. Mike Wickman's family made a \$100.00 donation in Mike's memory.

John reminded us that Mike was a founding member of the gun club. John suggested the new pistol range be named in honor of Mike.

After some discussion John made a motion to name the new pistol range the "Mike Wickman Memorial Pistol Range", and a sign to be placed on the building. Tom seconded the motion. All approved.

Then, Brad suggested the sign be metal like the Norm May Range Sign.

John amended his motion to specify the sign would be metal. Richard W. seconded the amended motion. All Approved.

Tanya made a motion for the club to pay for the sign. Ed seconded the motion. All approved.

Brad will work with Darin Lasley to get a sign made.

Brad will prepare a Thank You note to Mike's wife for the family's donation.

2. Richard Cooper brought up BM 114. Richard C. will work with Richard W. to get information out to the membership regarding this BM. Kellie stated that she has shared information on her personal FB page. Some have posted signs.
3. Dave McCarty representing the youth trap club said they will be done using the gun club facility on October 29<sup>th</sup>. Dave thanked the gun club for allowing them to use the facility. Dave said one JV girl has done exceptionally well and took first place at state competition.
